Note: mares with foals required to purchase a stall.

ALL FOALS MUST BE LEAD IN HAND OUTSIDE OF STALL. FOALS MAY NOT BE LOOSE & EXPECTED TO FOLLOW THEIR DAMS

Braiders and professional handlers will also be available on site. Please indicate on attached form if you will be requiring these services & how many. Available on first-come, first-serve basis. Please contact Shannon with questions regarding services.

Fees:

Box stall: \$60/night

Trailer-in/grounds fee: \$25/horse per day. Mare with nursing foal counts as one horse. Grounds fee waived if stabling.

Handling: \$50/per horse or mare with foal/per class. If mare AND foal are to be presented, they each require a handling fee.

Braiding: \$40/per horse or \$75/per mare & foal pair

Fees in red must accompany attached form to hold stabling. Check must be made to El Sueno & will be held until keuring. Please bring check or cash for braiding and CASH for handler (handler may be Dutch & traveling with jury).

Accommodations: Good Nite Inn (7 mi) 805-388-5644; Hampton Inn & Suites (7.5 mi) 805-389-9898; Motel 6 (6.5 mi) (805) 388-3467.

Notes: Ample trailer parking available. No hookups. Dogs must be kept on leash at all times. Breakfast will be provided; lunch available for purchase on site.

Directions: *From Highway 118/23:* Go west on Los Angeles Ave/Highway 118 toward Camarillo. In approx. 8 miles, turn right on Donlon Rd.

From Highway 101: Exit at Lewis Rd/Highway 34 and head north. Lewis Rd will dead end after 4 mi at Los Angeles Ave/ Highway 118. Turn right and prepare to make immediate left on Donlon Rd.

After turning onto Donlon, keep left at fork. Make left turn onto Kingsgrove Dr after 1.2 mi. Arrive at 5250 Kingsgrove Dr on the left – dirt road with signage for El Sueno Equestrian Center.

EL SUENO LIABILITY AGREEMENT

OWNER/AGENT RIDER/HANDLER TRAINER

This document waives and releases important legal rights. Please read it carefully before signing.

I understand and expressly acknowledge that I am fully aware that horseback riding and jumping, horse sports, and my participation in the Horse Show competition involve inherent dangerous risks that include, but are not limited to, the risks of accident, loss, serious bodily injury, property damage, and/or death ("Harm"). I hereby agree to expressly assume ALL RISK OF HARM to myself and my horse(s), and choose to voluntarily participate in this Horse Show. I HEREBY EXPRESSLY, VOLUNTARILY, AND UNCONDITIONALLY RELEASE, INDEMNIFY AND HOLD HARMLESS El Sueño Equestrian Center, Lisa Ciesniewski and/or Kimberlee Farms, their owners, officers, members, agents, employees, licensees and invitees, as well as any other person, firm, corporation, company, entity, or anyone in any way connected with the ownership and management of the show premises and the Horse Show, or in control of the premises or equipment related thereto (collectively, "Releasees") from and against ANY AND ALL CLAIMS FOR INJURIES, DAMAGES, AND/OR LOSSES connected with participation in the Horse Show. This includes, but is not limited to, claims for monetary damages, attorney's fees, costs, losses, and/or causes of action against Releasees for any and all HARM to me or my horse(s) and for any HARM caused or contributed in any way to by me or my horse(s) to others, arising out of or in any way connected with participation in the Horse Show, and includes reimbursement of Releasees' costs and attorney's fees incurred in defense of such claims. I further agree to this release, indemnification, and holding harmless WHETHER OR NOT SUCH CLAIM, INJURY, DAMAGE, OR LOSS RESULTED, DIRECTLY OR INDIRECTLY, FROM MY NEGLIGENT ACTS OR OMISSIONS OF THE NEGLIGENT ACTS OR OMISSIONS OF RELEASEES, to the fullest extent allowed by law. I also acknowledge that no representations or warranties, whether oral or written, implied or expressed, have been made by Releasees concerning the Horse Show premises, the Horse Show Event, or the activities at El Sueño Equestrian Center and/or Dark Horse Farms, or any other matter. I understand and agree that this Release, Assumption of Risk, Waiver and Indemnification shall be binding upon my heirs and assigns. If a parent or guardian is signing below, he or she consents to the minor child's participation in the Horse Show and agrees to all of the above provisions and agrees to assume all of the obligations of this release of liability on the minor child's behalf.

I HEREBY DECLARE THAT I CAREFULLY HAVE READ THE FOREGOING RELEASE OF ALL LIABILITY, I AM FULLY AWARE OF THE LEGAL CONSEQUENCES OF SIGNING BLEOW, AND I AGREE TO THE TERMS OF THE RELEASE IN FULL.
